He has worked on a variety of major projects such as railway, tunnelling works, highways, bridges and commercial developments in Hong Kong and overseas for both contractors and stakeholders. His experience includes forensic research of planning and programming issues, preparation of extension of time claims and delay analysis as well as engineering design, site supervision and project planning. He is an NEC4 Accredited Project Manager.

2019 to date – Senior Consultant (Delay), Contract Dispute Consultants HK Ltd., Hong Kong

Adrian provides support to clients in relation to claims, planning and delay issues. His current assignments include:

- Assisting a contractor on a TBM tunnelling project in Singapore preparing extension of time claims for changes to ground conditions;
- Assisting a contractor involved in the construction of a large hospital project preparing extension of time claims for changes to the works in Hong Kong;
- Providing arbitration support to a piling contractor in a dispute with a subcontractor regarding late completion of works on a basement construction project in Hong Kong;
- Assisting a joint venture to identify and prepare claims for additional time and cost arising from the demolition, reconstruction and development of a hospital in an urban area in Hong Kong; and

• Hong Kong Express Rail Link - 822A – HK\$3.2bn

This project involved the construction of a 27km dual-track tunnel with central dividing wall, two ventilation buildings, a ventilation shaft and a vehicular access road for the Hong Kong-China High Speed Rail project. Adrian was seconded to the MTR's internal disputes team to review all of the contractor's time entitlement claims and to notify the dispute manager of any potential valid claims including:

- Assessing the contractor's submitted baseline programmes against the factual records to determine the areas of delay(s) and prepared factual narrative;
- Preparing presentations and time-chainage charts to determine the as-built blasting sequence;
- Reviewing the engineer's assessments and contractor's time entitlement claims and draft position papers.

• Taiwan High Speed Rail Signalling Installation – HK\$3bn

This project involved the installation of signalling equipment for the Taipei High Speed Rail project. Adrian assisted Siemens in creating the as-built chronology and programme for various installation tests using as-built records including:

- Programme analysis to determine the duration of activities, and the logic and critical path(s);
- Collaborating extensively with the Siemen's engineering team to ensure that the as-built programme was accurate and key differences against the baseline programme were identified;
- Assisting with time-impact analysis to ascertain the windows of delay.

• Hong Kong Express Rail Link - 810B – HK\$3.3bn

This project involved the construction of the southern portion of the West Kowloon Terminus for the Hong Kong-China High Speed Rail project. Adrian was seconded to the contractor's team undertaking delay claims related to the station excavation preparing detailed chronologies to substantiate identified periods of delay.
